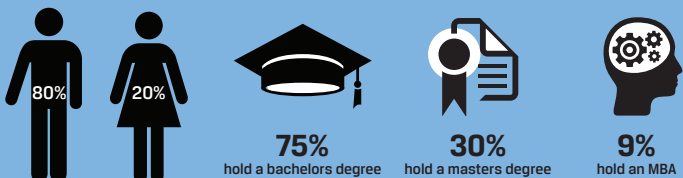

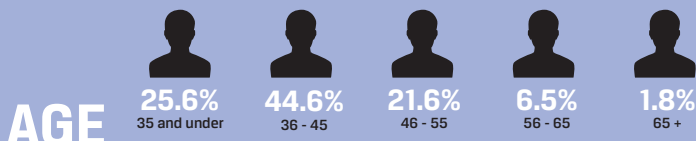

Posting a Position

To place a position on the Career Centre, email a PDF or Word document of your posting to jobs@cfatoronto.ca. The posting should be a maximum of one page in length (8.5" x 11"). An example of the standard format we use for the job listings is shown below. Clicking on the link brings the potential candidate to the PDF of your posting. We will provide you with a screen shot of your posting after it is placed on the website to confirm that it is actively posted. You will receive an invoice within one week after you place the posting. You may pay by Visa, MasterCard, American Express, or cheque.

Pricing Options

FIRST TIME POSTERS:

For first time posters, the cost to place a job advertisement is \$1,200 plus applicable taxes.

REPEAT POSTERS:

Once your organization has posted a position with us, you will be charged a rate of \$1,000 plus applicable taxes as a repeat poster.

ANONYMOUS POSTINGS:

You are able to remain anonymous and have CFA Society Toronto collect resumés on your behalf for a fee of \$100 plus applicable taxes. Applications are sent by email to you daily or weekly, depending on your preference.

PAID INTERNSHIP POSTINGS:

Employers may post one-page paid internship positions on our site for the cost of \$400 (plus applicable taxes).

SOCIAL MEDIA & E-NEWSLETTER POSTINGS:

Over 3,000 CFA Society Toronto LinkedIn Group members will see your position promoted in our members-only discussion board. Your your position will also be included in our bi-weekly e-newsletter to over 8,500 CFA Society members.

LARGE-VOLUME POSTERS "PREFERRED RATE":

- Preferred posting rates are offered only to companies who keep their account within good standing with CFA Society Toronto.
- You may use only one job title per posting.
- You may not post any ad that links to a variety of postings on another website. (For example, you may not use the job title "Various Positions" with a link to several different job openings on your own website.)
- We consider the reposting of an ad 90 days after the original posting date to be ordering a new ad, and therefore regular rates apply.
- We do not guarantee a certain number of responses.
- We reserve the right to refuse a posting or remove an organization from the recruiter section.
