# CEO

Message from Frederick Pinto, CFA, ICD.D



This past year was hugely successful for CFA Society Toronto and marked the first year of our three-year transformational strategic plan. Our plan is guided by our North Star: to enhance and expand our diverse community to promote an ethical, dynamic, and vibrant investment and financial services industry. It is supported by three pillars: Member Experience, Influence & Impact, and Operational Excellence.

#### **Member Experience**

Our most important objective this year was listening. We engaged Environics Research to conduct an independent member engagement survey to understand needs, surface engagement insights, and identify the drivers, barriers, and opportunities that differ by career stage. Those findings now anchor one of our key FY2026 priorities: designing and delivering cohort-based programming for early-career, mid-career, and established/senior members.

We also refreshed our volunteer program, moving from a limited, standing-committee model to a strategic, flexible structure with three oversight steering committees, so more members can contribute meaningfully. To make learning more convenient and career-relevant, we launched the Learning Partner Portal, a curated hub of high-impact courses and certifications with member discounts that will continue to expand.

#### Influence & Impact

We established several content committees, including a Strategic Content Steering Committee, *The Analyst* Editorial Committee, a Digital Content Committee, and a Social Media Committee, to enhance how we plan, produce, and amplify ideas. We introduced new content formats, such as our Diverse Dividends video podcast series, and leaned into proactive, brand-building, multi-channel storytelling across new social media channels. As a result, our audience grew by over 40% (from ~31,000 to 43,580+).

We also deepened industry partnerships to amplify our voice and unlock utility for members: collaborating with VersaFi on the Equity Equation Survey, with the Industry Standards Reporting Research Council on its Global Corporate Disclosure Survey, and co-hosting the launch of ALTSCAN 2025 with CAIA and Markets Group. A significant achievement was launching the Next Gen Program, expanding our pipeline from secondary schools through universities/colleges to CFA Program candidates; enhancements to university relations increased engagement, with student participation up 52% and university participation up 20%.

#### Operational Excellence

Behind the scenes, we strengthened the capabilities that support member value. We completed an office refresh with upgraded event-space technology to enhance in-person experiences; and implemented a standard committee management process so volunteers encounter consistent expectations and support across all committees. We also began development of a new corporate website designed to enhance online engagement and clearly communicate the value of membership.

CFA Society Toronto membership empowers you at every stage through the power of community, competency, content, and credibility. Build relationships that open doors, accelerate learning, and raise your profile within a nearly 12,000-member community. Stay current and competitive with future-ready skills development and practical, career-stage-relevant insights, when and how you want them. Strengthen your reputation with employers, clients, peers, and the public through your association with our Society and the standards we uphold.







## Influence & Impact

#### Amplifying our influence and impact within the investment and financial services industry

The second pillar of the 2025-2027 strategic plan focuses on amplifying the Society's Influence & Impact. There are two key goals within this pillar, the first of which pertains to industry leadership, and involves amplifying our collective voice to shape the future of finance. The second highlights professional recognition, and aims to elevate the profile of CFA charterholders in the industry.

To achieve these goals, we are expanding our reach through digital media, including podcasts and videos, and to develop partnerships with key strategic partners for exclusive learning opportunities that will shine the spotlight on the Society and what it has to offer professionals in the industry.

Key measures in this pillar include increasing our digital presence, developing more strategic partnerships, achieving increased media mentions through public relations efforts, increasing volunteer engagement, diversifying revenue streams, and expanding influence as a champion for inclusivity.

The Society made great strides toward increasing our visibility in 2025, achieving 40 per cent growth in audience over 2024 (e-news subscribers, social media followers, new website visitors, etc.). This growth was primarily driven through social media and our social content strategy that has expanded beyond an event focus to highlight our member community. We also introduced new social media channels - Instagram, TikTok, Substack - as well as new forms of content, including the Diverse Dividends video series, which highlights leaders in the industry and provides insights and inspiration to those focused on career advancement.

On the partnerships front, we took a strategic approach to partnering with other organizations, and mobilized our volunteers to assist us in creating connections with other relevant businesses in the industry. This led to the development of new strategic partnerships, including with VersaFi (formerly WCM), Markets Group, and the Financial Management Institute of Canada (FMI). We also launched the Learning Partner Portal to help deliver curated content through courses and certification with select learning providers, and established event partnerships to help build our brand awareness through event and conference partnerships.

Another key driver for future growth is our Candidate Pipeline initiative, marking the introduction of the Next Gen Program, which looks to bring pre-member audiences into the fold, our engagement of the Society with high school and university students and candidates as we support the next generation of CFA charterholders.


